THE NAVGHAR police have arrested two more accused for the alleged murder of a 30-year-old sanitary worker in Bhayandar who was lynched at his workplace earlier this his workplace earlier this month on suspicion of being a thief. In all, eleven people have been arrested and the police added sections of the Scheduled Castes and Scheduled Tibes (Prevention of Atrocities) Act, 1989, on Wednesday as the deceased was from the Dalicommunity. The incident took place on May 7 when the deceased Krishna Dusamad, 30, a sani-



Non-cognizable complaint lodged over threat to Raj Thackeray on loudspeaker row


